RELEASE, HOLD HARMLESS, AND INDEMNITY AGREEMENT

West, her agents, representatives, employees; the Department of Natural Resources of the State of Georgia, its employees and agents; and any other person for or to whom they may be liable (herein collectively referred to as "Sponsors") from any and all claims, liabilities or demands for personal injuries or property or other damages arising out of or in any manner connected with this visit to Ossabaw Island, including proceeding to or from Ossabaw Island.

I further agree to indemnify and hold harmless the Sponsors from and against any and all loss, liability, costs, claims, demands, damages, actions, causes of action, suits or expenses (including without limitation reasonable attorneys' fees and expenses) arising out of or in any manner connected with, related to or resulting from third party claims related to this visit to Ossabaw Island, including the travel to and from Ossabaw Island.
